**Re: The John Alexander Memorial Scholarship Fund, 2024-2025**

To Whom it May Concern:

We are writing to law schools in New York State to advise them of the John Alexander Memorial Scholarship Fund administered by the Schenectady County Bar Association.

The Fund was established in 1980 by the Last Will and Testament of Elizabeth M. Alexander, widow of John Alexander. The Fund was created to provide scholarships for Schenectady County residents. The conditions for receipt of the scholarship are that the applicant reside in Schenectady County and be a full-time candidate for a Juris Doctor or Bachelor of Law Degree at an accredited New York Law School.

The income of the trust and the number of applicants determines the amount of the scholarship to be awarded to each recipient in a given year. As such, there is no set amount awarded for the scholarship from year to year. Last year, there were 20 recipients, each of whom received \$1,550.

Submissions should be received **no later than December 1, 2024.**
